

A Note From Mrs. Kerper

Dear Families,

It is hard to believe that our school year is almost half over already! There is still so much to do! Your child may have told you that we have been talking about attendance a lot lately. Good attendance is so important to school achievement. We monitor it daily and post it. In fact our best attendance rate this year has been 97.8 percent of the students here and the lowest number of tardies so far has been 12. Those numbers are great, but we don't get close to them very often. If the students beat these numbers we will have a school-wide reward. While we know we cannot be perfect and students need to stay home when they are ill, we have a lot of room for improvement. Only 5% of our students have been at school every day so far this school year. That is a terribly low number this early in the year. Please help your child. Good attendance at school is a predictor of success in the workplace as an adult and we want all of our kids to be successful!

The holidays can be an exciting time for all of us, but it can also be a stressful time. Remember that children need rest and routines. Please do all that you can to keep things as regular as possible for your children during this busy time of year. Stay consistent with homework routines, bed times, and behavior expectations. It will help your children get the most out of the learning time before break. There will be plenty of opportunities to stay up late and celebrate over the vacation time.

Due to the winter break I usually combine the December and January newsletters. Therefore, another one will not be coming until the first of February.

Plan some fun activities to enjoy over the winter break with your children. If they do not have a library card, please consider going to the public library to get one. All you need is a photo ID and proof of address, such as a piece of mail.

2014-2015 School Year PATRON NOTIFICATION

Between District Open Enrollment

Iowa Administrative Code 281-17.3(2)

Parents/Guardians considering the use of the open enrollment option to enroll their children in <u>another</u> public school district in the state of Iowa should be aware of the following dates:

DEADLINES:

March 1, 2014 is the last date for regular open enrollment requests for the 2014-2015 school year.

September 1, 2014 is the last date for open enrollment requests for entering kindergarten students and those students falling under the "good cause" definition for the 2014-2015 school year. To insure that the transfer of individual students does not adversely affect the diversity plan of the District, certain limitations to open enrollment have been established. **Parents of kindergarten students are therefore encouraged to make application requests prior to March 1, 2014.**

APPEALS:

Within 30 days of a denial of an open enrollment request by the DMPS Board of Education, a parent/guardian may file an appeal with the state board of education only if the open enrollment request was based on repeated acts of harassment or a serious health condition of the student that the district cannot adequately address. All other denials must be appealed to the district court in Polk County.

ATHLETIC ELIGIBILITY:

In most cases, a high school student who open enrolls is <u>ineligible</u> for varsity athletic competition during the student's first 90 consecutive school days of enrollment in the receiving district. Some, but not all, exceptions to this general rule of ineligibility are as follows:

The sending district does not offer the sport in question.

The sending district was dissolved and merged with one or more other districts.

The sending district whole-grade shares with another district for the student's grade level.

TRANSPORTATION:

Parents/Guardians of students open enrolled <u>from another school district</u> are eligible for transportation assistance if the household income of the parent/guardian is at or below the federal poverty guidelines for household size. <u>The two districts must be contiguous</u>. Assistance may be in the form of actual transportation or in the form of a cash stipend. Information regarding transportation eligibility and a complete copy of the District's open enrollment policy and procedures may be obtained from the Open Enrollment Office, 1301 Second Ave., Des Moines, Iowa 50314
